Subject: Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015 regarding termination of the Master Services Agreement with Government of Punjab.

Dear Sir / Madam,

In compliance with the provisions of Regulation 30 of SEBI (LODR) Regulations, 2015, we hereby inform your good office that BLS has today received Notices from the Government of Punjab regarding the termination of the Master Services Agreement.

The Agreement was terminated by Government of Punjab in view of their precarious financial position and their inability to pay our dues as per their commitment. No deficiency in service on our part has been reported for termination of the contract.

We are engaged with the Govt of Punjab regarding the process of closure of the contract, and the payment of our dues over a period of next 6 months. We are also in discussion with the Government to see the possibility of continuing the contract at a reduced scale.

In addition, we are also looking at an alternative delivery mechanism for various non Govt services to the citizens of Punjab, and other States, to continue along our growth path.
