James Bond carmaker finds new CEO from German Black Forest

BLOOMBERG Frankfurt, May 26

ASTON MARTIN LAGONDA Global Holdings Plc's new chief executive officer grew up faraway from the glitzy luxuryresorts featured in James Bond films, but a different leading man might just help reverse the fortunes of the cashstrapped manufacturer best known for making 007's vehicle of choice.

Tobias Moers, a German engineer from the rural Black Forest region, has been spearheading growth at Daimler AG's Mercedes-AMG performance division for the past seven years, expanding the unit's product line and about quadrupling vehicle sales.

Now Moers is assuming the hot seat at Britain's iconic carmaker, which has tried to emulate the success of Italian peer Ferrari NV yet lost more than 90% since going public in 2018. Canadian billionaire Lawrence Stroll threw the manufacturer a fresh lifeline with a sizable cash injection in March, but the coronavirus crisis that has shuttered showrooms and dampened consumer demand is complicating recovery

Moers, a 54-year-old father of two who worked at one of Germany's first electric-car startups, signalled he'd be fit for the job as far back as a year ago.

"My ambition is to take on more responsibility, I'm a strategist," Moers told German newspaper Die Welt, which called him Daimler's "hidden champion"in a story published in February 2019. "I know how the big picture works, and have the view for the essentials."

Aston Martin shares surged on Tuesday following the announcement that Moers would take over from Andy Palmer in August. Moers couldn't immediately be reached for comment.

पिछले दिनों भागलपुर-बांका के मुसाफिर दरभंगा उतारे गए। वहां से बस से लाया जा रहा था। नवगछिया में खरीक के नजदीक ट्रक से टक्कर हो गई। छह लोग जख्मी हए थे। टक पर सवार नौ मजदरों की मौके पर मौत हो गई थी। जयपर से भागलपुर 24 घंटे का सफर है। सोमवार शाम ट्रेन 48 घंटे में पहुंची। इस ट्रेन पर सवार बांका के महेश पंडित और भागलपुर के संतोष कुमार ने भी भोजन-पानी न मिलने की शिकायत की। इसी ट्रेन पर सवार मुजफ्फरपुर के उमाशंकरए संजय यादवए बेगूसराय के रोहित कुमारए खगड़िया के रौशन कुमार को अपने घर पहुंचने में अभी भी दुश्वारियां झेलनी बाकी थी। इन्होंने कहा पानी के लिए तरस गए।

नेहरू विश्वविद्यालय (जेएनयू) छात्र संघ के पूर्व अध्यक्ष और भारतीय कम्युनिस्ट पार्टी (भाकपा) के नेता कन्हैया कुमार ने कहा कि पूर्णबंदी के दौर में छात्रों को बिना किसी अपराध के गिरफ्तार करना अंग्रेजी सरकार की याद दिलाता है। उन्होंने मांग की कि गिरफ्तार किए गए छात्र नेताओं को तुरंत रिहा किया जाए। कन्हैया दिल्ली में गिरफ्तार किए गए छात्रों के संबंध में विभिन्न छात्र संगठनों की ओर से आयोजित वीडियो कॉन्फ्रेंस के माध्यम से आयोजित प्रेस वार्ता में बोल रहे थे।
