The company has already intimated to stock exchange on January 30, 2018. Further, total outstanding receivables as at December 31, 2018 from Government of Punjab are Rs 12,308.88 lakhs.
- The profit from Visa and Consular Services is Rs. 1,650.52 Lakhs for the quarter ended December 31, 2018.
- Consolidated profit before tax have been impacted by Rs. 751.62 Lakhs on account of closure of the Punjab contract in three of Indian subsidiaries, even as Management is making continuous efforts to seek alternate source of business and revenues.
